Emergency shelter transportation will be provided for students who are residing at one of the following shelters:

- WCH at 101 Wellington Road; WCH at 450 Clarke Road; Rotholme at 42 Stanley Street; Zhaawanong at 256 Hill St; Women's Emergency Centre at 975 James St, Woodstock; Elgin County Women's Shelter at 76 Wellington Street, St.Thomas; and Women's Rural Resource Centre at 145 Beech Street, Strathroy;
- Pickup and drop-off will be at the shelter and school only;
- Under normal conditions it can take up to five working days to arrange transportation;
- Applications that do not meet STS policies and procedures and incomplete applications will be returned to the School Board designate.
